In addition, the following annual fees apply:

- Non-refundable registration, assessment & a medical fee of AED 500 each
- Digital & Physical resource fees cover vital and integral learning materials used throughout the school, providing an excellent quality of education. This also covers yearly GL/CAT4 and other required assessment fees where applicable
- GCSE and BTEC exam & course fees are charged separately

Digital & Physical resource fees and medical fees are payable at the beginning of the academic year or in the first term of your child joining the school.

Please note that uniforms, school trips, chrome books, after-school care programs, meals, transportation, and events are provided by third parties and are charged separately.

Payments:

- The School fees are paid in three installments. Term 1 fees MUST be paid in full by 1st Aug with Term 2 and Term 3 are to be paid by 1st Dec and 1st March respectively.
- Failure to meet payment timelines will result in the withholding of your child's termly/annual reports. Parents will receive a maximum of three "payment notices" to remind them of overdue payments; if these are left unattended, affected students will be given a suspension in line with the KHDA regulation. After this, the school reserves the right not to re-register your child for the following academic year, as per KHDA regulations.
- The School reserves the right to initiate legal action against any bounced/returned cheque. There will be a penalty fee of AED250, which will be added to a pupil's account for any returned cheque.
- Discounts are applied to your Term 3 invoice and are only given to students who complete a full year at Star International School Mirdif.

New Enrolments:

- At the time of accepting an offer, a non-refundable Registration Fee & Assessment Fee of AED 500 each must be paid.
- An enrollment of 10% of the tuition fees for the forthcoming academic year must be made within seven days of receiving an offer of a place. This 10% enrollment is deductible from the first term's tuition fees. This amount is non-refundable unless the family has to move outside the Emirate of Dubai before the start of the academic year. The School reserves the right to ask for proof that the family is moving outside the Emirate of Dubai. Failure to make the deposit payment at the time of acceptance will mean your child's seat is not guaranteed.

Existing Pupils:

- A re-enrollment fee of 5% must be paid to guarantee a place for their children for the following academic year. The re-enrollment fee will be deductible from the first term fees.
- The re-enrollment fee is non-refundable unless the family has to move outside the Emirate before the start of the academic year. The School reserves the right to ask for proof that the family is moving outside the Emirate of Dubai

























KHDA Approved Discounts:

Siblings Discount:

- 10% discount for the second child in the family, applicable on discounted fees
- 15% discount on the third child in the family, applicable on discounted fees
- 20% discount on the fourth child and following children in the family, applicable on discounted fees

Privilege Cards and Corporate Discounts:

- Emirates Platinum card: 20% applicable on discounted fees
- Fazaa Card: 10% applicable on discounted fees
- Esaad Card: 10% applicable on discounted fees
- Al Futtaim employees: 10% applicable on discounted fees
- Majid Al Futtaim employees: 10% applicable on discounted fees
- Al Ghurair employees: 10% applicable on discounted fees











All the discounts are to be reflected on the last term payment. If any of the payments are delayed, the discount will be revoked. Discounts will apply only if the student completes one full academic year. If the child is withdrawn during the academic year, no discounts apply.

Please note that only one discount can be applied per child.

All privilege and corporate discounts need to be provided and confirmed by families at the beginning of the Academic Year - Please note that the school cannot apply the discount in the middle of the Academic Year

Notice of Withdrawals:

Parents wishing to withdraw their child from the school must fill in a withdrawal form with the Registrar.

Non-payment of tuition fees:

When fees are not paid in any mode of learning, the school reserves the right to:

- Suspend students from learning for a maximum of 3 days per term, excluding exam days.
- Not re-enroll students for the following academic year. This will be documented by the school through the issuance of dated warning letters.
- Withhold students' progress reports and to refer the issue to the KHDA.
- Not issue the Transfer Certificate.

Refunds:

Tuition fee refunds will be calculated as follows:

- Fees will be charged for one full month if the pupil attends school for two weeks or less.
- Fees will be charged for two full months if the pupil attends school for more than two weeks and less than one month.
- Fees will be charged for the full term if a pupil attends school for more than a month.

Kindly note it will take up to 30 days to process refunds.

As per KHDA regulations, the value of the school fee per month is calculated by dividing the total annual tuition fees by ten.
